How do we collect your data on WeClaim?

WeClaim will collect personal data such as names of respondents, gender, age, caste, ethnicity, vulnerability status, telephone nos., addresses and status of their enrolment under Government schemes through direct conversation and communication with the respondent, carried out by the user (anyone who downloads the App at their own free will) of the App. All the data entered will be stored at the backend console, which will not be accessible to the users of the App once the data has been submitted through the App. Only those organisations and individuals authorised by NCDHR will be able to access the back-end dashboard to enable immediate interventions with state authority in order to facilitate access to entitlements by the poor.

What do we use your data for?

The data will be used to locate the communities, specifically, the SC, ST, Minority and other marginalised communities to access state entitlements and assist them in securing these by engaging with the local administration. Secondly, the data will be used for informing Humanitarian sector, the Government and stakeholders at all levels to usher in inclusive disaster relief, response, recovery and rehabilitation.

What rights do you have regarding your data?

The respondent and the authorised App user have the right to request information about your stored data and the purpose of its collection at no charge. You also have the right to request that it be corrected, blocked, or deleted. You can contact us at any time using the address given in the legal notice if you have further questions about the issue of privacy and data protection. You may also, of course, file a complaint with the competent regulatory authorities.

Social media

The data collected through the App by general users, without the authorisation and moderation by NCDHR, should refrain from posting respondent details and information that can easily identify them on any social media networks like Facebook, Twitter, or Google+ etc. or used for promotional purposes. NCDHR will not be liable for any such act by a general user. Any unauthorised user found engaging in such acts will be liable for legal action under the concerned law.
